#### **7. Education/Academic Update** **John Fry** **20 minutes**

Introduction of Special Education Leadership and SPED program and SEAC.

We are having around 13.6% of students who get SPED services.

We are continuing to hire one SPED teacher and two paras.

Salaries are more competitive when it comes to paras and initial teachers.

SEAC meets once a month with different topics per meeting. Families with students who get SPED services and SPED staff can attend.

#### **8. Discussion- Administration Updates:** **Holly Fischer** **30 minutes**

Update regarding enrollment, activities and events at school, Rebranding status and open positions for employment.

- 80% of the families attended conferences.
- Today it was a PD day. One session was with Eli Kramer to talk about Teach Like a Champion. In the afternoon we had Vonnie Vayder talk to us about behavior and what she has seen as she works with high behaviors in other places.
- Volunteer hours: 204 hours since the last meeting. 146 spent on field trips. Other activities are lunch help, library organization.
- Substitution has been a struggle. Andrea Harverson is adding the role of substitute coordinator. We are struggling to get same day substitution from our substitute companies. We continue to hire substitutes.
- We have started looking at the schedule for next year.
- We have been doing some research on early start. In the past, our bus company couldn't do it but now they can. We need to find a way for teachers to be able to support the students better and giving them an additional hour a week could improve the collaboration time and planning for our individualized approach that we have in our mission.
- Enrollment: 969 students with 2 offers out.
