- Sections per grade stayed the same from previous year. Less 8th grade sections scheduled due to enrollment loss in this area.
- Increase in middle school retention this year
- Dip in waitlist of about 150 students on the list
- MCA test results: majority of grade levels exceed the state average
 - 5th grade reading and science and 3rd grade reading are goals for improvement
- FOE goal: MCA scores, goal not met
- Goal: all kindergarten students ready for school: met
- Goal: closing achievement gap in free reduced students: exceeded goal; DVA continues to achieve higher than the vast majority of the state in subgroups
- Goal: college and career readiness: Not met
- Initiatives for 23-24
 - data driven instruction
 - curriculum review process
 - instructional coach hired
 - recommitted to PBIS
- Equity committee hosted 2 community events in 22-23
- Fundraising increase of 144%, but shy of goal set
- Many enrichment activities resumed in 22-23
- Mental health supports increased for families and students
- Differentiation coach for teacher support added
- Late start Mondays were implemented to decrease staff stress levels.
- The annual report will be available on the website.
