Student Behavior Management Procedures

Unacceptable Behaviors/Offenses and Discipline Procedures

Category One

Student behaviors in this category are usually handled by the classroom teacher.

For repeated Category One behaviors, a discipline referral will be written while the behavior becomes a Category Two offense.

Examples of Category One behaviors include but are not limited to these behaviors:

- Disruptive in classroom
- Not following school procedures including lunch and recess
- Loitering in the hallway and other areas
- Running/excessive noise in halls or school
- Other

Category Two

Student Behaviors in this category result in a Discipline Referral being written and possible consequences listed below.

Examples of Category Two behaviors include but are not limited to the behaviors listed below:

- Use of profanity/innappropriate gestures
- Insubordination, refusal to follow rules/directions
- Bullying
- Property misuse
- Fighting
- Lying, cheating, plagiarism or forgery
- Technology violations
- Repeated Category One offenses
- Disruptive Behavior
- Pushing, shoving or scuffling
- Other, including Bus Offenses

Discipline Procedures for Category Two Behaviors

Discipline Referral is Written
Student meets with Student Success Team member
Parents/Legal Guardians Contacted
Consequence is issued
Follow Up with Teacher/Staff Member

Category Two Possible Consequences

Verbal/Written Warning
Detention during Lunch
Alternative Recess
Detention Before or After School
Possible Restitution
Behavior Contract
In-School Suspension
Out-of-School Suspension
Suspension from the Bus
Expulsion

Category Three

Student behavior in this category will result in a Discipline Referrals being written and possible consequences listed below.

Examples of Category Three Behaviors include but are not limited to the behaviors listed below:

- Weapons or look-alikes
- Assault
- Endangerment of others
- Sexual harassment
- Use of Intimidation
- Persistent bullying
- Vandalism
- Repeated Category One and Two Offenses
- Drugs, Alcohol, Tobacco, Vaping, other controlled substances, etc.

Discipline Procedures for Category Three Behaviors

Discipline Referral is Written
Student meets with Student Success Team member
Parents/Legal Guardians Contacted
Student/Parents/Legal Guardians Meeting
Consequence is issued
Follow Up with Teacher/Staff Member

Category Three Possible Consequences

Verbal/Written Warning
Behavior Contract
Detention Before or After School
In-School Suspension
Out-of-School Suspension
Law Enforcement contacted
Possible Restitution
Suspension from the Bus
Expulsion
