November 30, 2020 Board meeting minutes.

 Motion to approve the minutes of the November 30 meeting as revised by Joe, seconded by Andy. It passes unanimously.

2. Administration Updates – Ahava Silkey-Jones

60 minutes

Updates on COVID-19 response and changes to distance and hybrid learning, middle school transition to distance learning, and academic and assessment updates.

- Introduction to Kathy Miller, new business manager as of January 1. She has already had meetings with people from the school.
- Finance update about COVID funds: tech and additional staffing was covered by that fund.
- Learning Model: we are looking at the numbers in the county, We don't know if the student population numbers are accurate because families do not have to necessarily communicate that to school as we are in distance learning.
- We have gotten multiple good comments about the changes we have made to the program.
- We are offering activities in the afternoon that have different target populations. Between 20 to 30 students have attended.
- What would happen if we defy the Governor's order and open regardless of guidance? There is the possibility to put our charter in jeopardy and public funding could be withhold.
- We have had some students on site that receive Special Education services, ELL students, and students with specific needs.
- We are 100% of compliance on our website based on FoE.
- Academic review for Social Studies standards by MDE.
- We have the option to qualify for additional resources and funds because we have enough people that identify as American Indian at the school. Parents will also have access to a parent council.

3. Academic Update - Terry Moffatt

Update and academic performance and STEP testing.

- STEP assessment K-3 test: the last time done last year was in the middle of the second one taking it (out of 3) because we were shut down right in the middle of it.
- FastBridge test: out of the UofM. Reason to switch from NWEA to FastBridge: NWEA is changing some aspects that would affect previous data. FastBridge is a shorter test and has progress monitoring. Reading: 4-8. Math K-8.Several other FoE schools use this test instead of the NWEA.It was created to be done individually. This year it will be taken twice but next year it'll be taken 3 times a year.
