Enrollment total: 437

MCA test scores still embargoed. Our Qcomp goal for this year was to increase our reading score to 77.2% actual increase was to 78% (up 2%). Able to issue bonuses.

Changing playground from a mud field to an asphalt field with peaceful playground model. Will include grassy area with picnic tables and raised beds for gardening. Basketball hoops will remain where they are. Cost will come out of the community service fund.

Lunch vendor changed. This past year was the first year ever to more than break even on the food service.

Thursday before school starts is designated as an open house for parents/children to stop in and drop off school supplies & forms. New student/parent presentation will be August 6

First through Eighth Grade students start school on Tuesday, Aug. 12. Kindergarteners start Thursday, Aug. 14.

Need volunteers to ride busses with Kindergarteners the first two days. Parents will be asked to fill out a "luggage tag" label for each Kindergartener to remind teachers how they are getting home.

Have received approval on grant and final approval on the grant budget. May look at a new budget in Sept. based on how many are enrolled.

Four new teachers will be joining Davinci for the 2015/2016 year: music teacher, 6th Grade teacher, 4th Grade teacher, and a replacement for special ed. teacher.

8.1 Health plan review/approval HR/Comp Comm.

Dale Lieb: Davinci staff are currently receiving health care through Preferred One. The committee took three bids for the coming year. Preferred One is 18% higher than the current year; however, the other two bids are over 100% higher. Recommendation to approve renewal of Preferred One.

Dale Lieb: Life & Long Term Disability insurance is currently with Assurant. Recommending a switch to Standard Life - a 40% swing, including a voluntary add-on for staff who wish to purchase more life insurance & Short Term Disability.

Motion to approve switch to Standard Life – Matt Manning Motion seconded by – Nicole Persons

Discussion – STD – Debra: no waiting period if you enroll during open enrollment. Matt: Need 25% participation. Looking for ways to make maternity leave more affordable..

Unanimous approval

Dale Lieb: 403b Plan – voluntary plan can be offered in a Roth or standard IRA. Can put substantially more funds away than in a 401k. The company, AXA can make selections for investments and provide advice – willing to meet individually with employees. Have 12 other charter schools participating. No matching from the school at this time, but the option is there for the future. Recommend school adopt 403b plan with no match.

8.3 Board member transitions

Ross Meisner: There will be a transition as Dale Lieb is leaving effective following this meeting. We have really appreciated Dale's work and insight. One person has expressed interest in the position. We should look at several candidates to appoint to fulfill the rest of Dale's term (he's at the beginning of a 2½ year term). Dale Lieb expressed appreciation for a wonderful experience. Wants to continue to support Davinci and will continue serve on the ABC board. Other members expressed their appreciation for Dale's work.

Executive Director performance and compensation

Ross Meisner: Performance evaluation feedback from the board was all excellent. Matt Manning: recommendation of 8-10% increase in salary and bonus based on education goals. Ross: compensation increase is not significant and director is meeting every goal. No increase was given last year. Ross read evaluation comments from board members – all very favorable. Recommendation to increase the Executive Director's salary by 10% with no change to her bonus, effective July 1, 2015.

Retention bonus is given every three years. Recommendation to make Debra eligible for retention bonus from the time of her interim start date.

Matt Manning: ad hoc committee met with Jeff Eller and Kou Vang. Recommendation that we indicate to Kou Vang that we would like to engage him for the feasibility and guiding principles with expectation for further engagement.

Matt Manning: Walmart on 109th & Lexington is for sale. Will make Kou Vang aware of this. Also, looking into the possibility of some school districts having "mothballed schools."
