Presentation of School Development Committee of 2021-2022 fundraising goals and presentation by vendors for outdoor space development and shading: St. Croix Recreational and Northland Recreation (3:00 p.m.).

- Albrecht Company/St Croix Recreational
  - 10 feet tall, 15x30
  - \$23,176 for 1 or ~\$40,000 for 2
  - It would need to be taken down during the winter
  - In case of weather issues, it would most probably need to be replaced (~4,000).

  - o 8 feet tall, 15x30
  - \$19,662.50 for 1
  - 10 years warranty prorated from year 6 and it loses 20% of its value
