11.2 Introduction to AMAZEworks Anti-Bias Books as a Resource for Community Building Persellin 45 minutes

Discussion regarding the incorporation of the AMAZEworks books as a resource for teachers to utilize in assisting students and the community. The AMAZEworks resources utilize children's picture books to incorporate the tenets of Anti-Bias Education in order to create classrooms of equity and belonging. The Board will hear from DaVinci Teachers on their use of the resources and how it provides an opportunity to engage in meaningful discussions about identity, difference and bias. This can also be helpful in preventing biased-based teasing and mistreatment and maintaining a safe and supportive school environment. Students learn and feel better in classrooms where they feel seen and valued for all of who they are. Students learn about empathy, accepting oneself, respect for others, noticing and rejecting bias and standing up for themselves and others.

- Below are the various AMAZEworks themes that were presented by several DaVinci teachers. They explained the meaning behind each theme, research behind these themes, and how these themes are practiced in the classroom:
 - Mirrors and Windows Mrs. Severson (8th)
 - Empathy and Understanding Mrs. Baker (4th)
 - Healthy, Complex Identities Mrs. Marta (2nd)
 - Respect Across Differences Mrs. Metty (K)
 - Notice, Name & Reject Bias Mrs. Marta (2nd)
 - Responsiveness and Action Mrs. Dalske (Ren)
- All families have the ability to opt-out of any AMAZEworks book. They must notify Holly in writing about books they do not want students to read/be discussed with them.
- These stories have been used since 2021 to address unkindnesses between groups of students.
- It is considered to be a resource to augment the character development curriculum.
- We will reach out to the Muslim Advocacy Council and Idara suggested putting together guidelines to create a committee to advise on AMAZEworks as it relates to the DaVinci curriculum.



11.3 Discussion on Muslim Advocacy Council Soussi and Board 15 minutes
